Excerpts from Rancho Tinaquaic and The Chapel of San Ramon by John R. Wickenden In 1837, William Benjamin Foxen obtained a Mexican land grant for Rancho Tinaquaic. In 1860, Frederick Wickenden married Ramona, the daughter of "Don Julian" W. B. Foxen and Eduarda Del Carmen Osuna. Frederick built his house, with the help of local Indians, three miles from the Foxen's adobe. In 1875, on a hilly



prominence on the north end of their property, the site was purchased by the Wickenden's and donated to build the Chapel of San Ramon church. The money for the building came from Frederick selling his sheep. As 1875 was a dry year, Frederick drove his sheep north to the Salinas Valley where he found feed and grass. Driving them to Redwood City, he sold them for \$1 each. He purchased redwood lumber and shipped it to Port Harford, near Avila Beach. The chapel was built from this lumbar, with Frederick Wickenden, Thomas Foxen, and Chris Lawson doing much of the work. Benjamin Foxen's body was moved to the new church's cemetery where one can see his tombstone, a marble shaft meant to replicate the broken mast of a ship. In 1880, the original "Wickenden Adobe" was remodeled and enlarged with the redwood siding lumber to protect the adobe bricks. The house still stands today and is currently owned and enjoyed by descendants of Frederick & Ramona Wickenden.

### **Artifact Spotlight**

Jerry Olivera found this matchbox and donated it to the museum. The Rusconi Café at its original spot, owned by Filippe Rusconi from Ticino Switzerland. In Jan. 30, 1945, a P-38 crashed into the restaurant and killed the proprietor, Mrs. Rusconi, the cook John Doff, and the pilot. In October of 1945, they reopened at 506. S. Broadway (now vacant, once the Valley Farmer). Clifford "Bud" and Ethel Shaw bought Rusconi's and renamed it "Bud Shaw Barbecue Restaurant." Eventually, "Bud" was dropped and Shaw's restaurant was born. It relocated to its current location at 714 S. Broadway in the 1950s.

### Pioneer Spotlight: Dr. Henry Clay Bagby



Dr. Bagby came from Missouri to Santa Maria in 1883. He started a lively practice in the Ayres & Dobson Drug Store. He helped both people and animals as both a surgeon and a dentist. Dr. Bagby had an active social life attending farewell, anniversary and birthday parties. He was so popular there was a newspaper article where he visited the father of his future bride and spoke about marriage only to find out he was speaking to the scarecrow in the garden! Miss Laura May Morris married Dr. Bagby in 1885. Their son Landon was born in 1889. Dr. Bagby was active in the Knights of Pythias, the Masonic Lodge of Guadalupe and the Rotary Club. He was also active in politics as the secretary for the Democratic Campaign club in 1884 and ran for coroner in 1886, but lost. In 1912 he ran for Assembly of the 59th District and defeated C. L. Preisker in 1914. He was also elected multiple terms to the school board. Dr. Bagby, on a trip to San Jose, opened a new office and moved there. After a year, he moved back to Santa Maria and worked in the Jones building on N. Broadway. As a roaming dentist, he would visit Los Alamos working

out of the Depot Hotel. At the museum, we have a dentist drill and the story of a child running from him, the dentist, from the year 1906. Dr. Bagby was competitive in the hobby of wing shot and was finally defeated by L. M. Kaiser when he lost by two quail out on Fesler's field west of town. In 1886, he went shooting pigeons on Morris Bros. Ranch when he came face to face with a California lion. This did not frighten him enough to stop his love of shooting. It was a railroad crossing car accident, on his way to hunt ducks near Hueneme that killed Dr. Bagby in 1927.
